- \* The brightness of the supplement light is divided into five levels. Press  to brighten the light. Press  to dim the light.

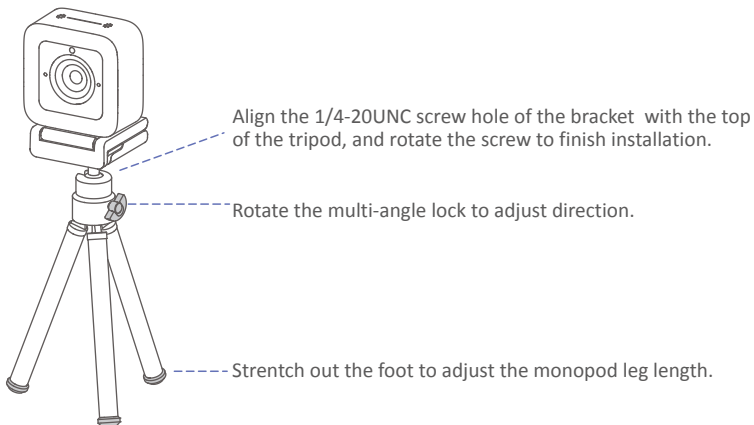

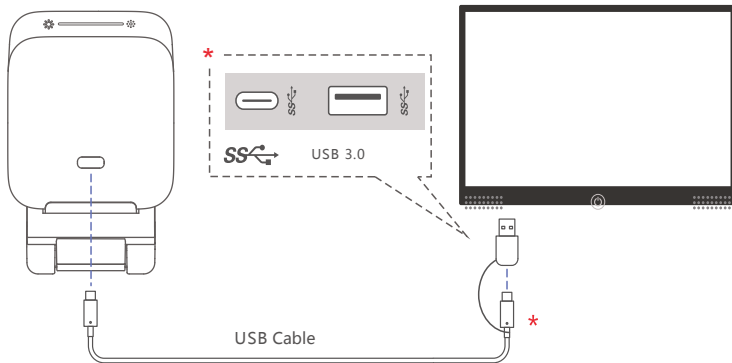

\*Connect the device to intelligent terminals, such as computers and conference flat panels.

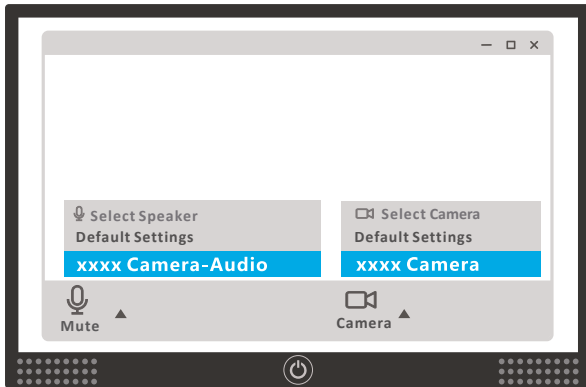
\*It is recommended to plug into USB3.0 interface of the terminal.

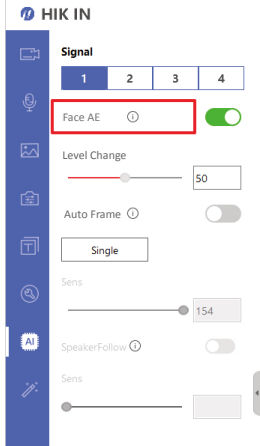
### \* Face AE

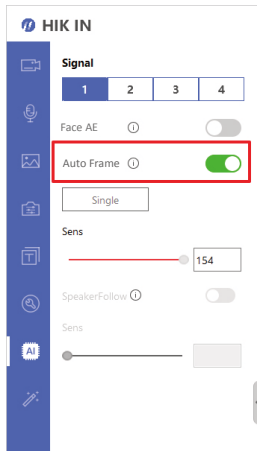


## \* Auto Frame

- \* Auto Frame is supported by AI series cameras.



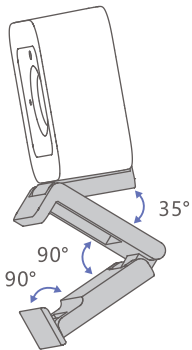
- \* The above picture is a screenshot of HIK IN interface.

Three sides of the camera can be magnetically attached to the bracket, allowing free switching between landscape and portrait mode.

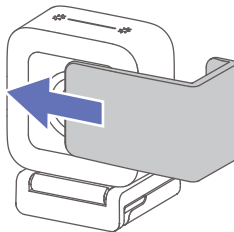


- Angle Adjustment
